## Position Description Deputy Coroner

**PRIMARY OBJECTIVE OF POSITION:** Under general supervision, performs the duties of the Office of Coroner as directed. Assignments include investigation, analysis, and explanation of cause of human death when requested or required by law. Work varies little, however individual judgement within prescribed standards and procedures and/or statutes may be required.

**ESSENTIAL JOB FUNCTIONS:**

- Physical requirements may include lifting up to 100# (greater with assistance), bending, stooping, walking, sitting, reaching, pushing and pulling.
- Work may be performed in undesirable outside conditions in which heat, cold, and dampness may be encountered and hazards may be present with exposure to chemicals and disease.
- Must complete required training within twelve (12) months of hire and maintain continuing education requirements during employment.
- Must possess a valid Montana Operator's License.

**MAJOR AREAS OF ACCOUNTABILITY AND PERFORMANCE:**

- Upon direction, investigates, analyzes, and seeks explanation for cause of death of persons within the County;
- Documents results of analysis and provides reports to the appropriate authorities as may be required;
- Frequently works with professionals that may have varying opinions as the substance at hand;

**MAJOR AREAS OF ACCOUNTABILITY AND PERFORMANCE: (Cont.)**

- Assist the Coroner as directed; and
- Performs the duties of the County Coroner in his/her absence;
- Works regularly with information that may be limited;

- Work requires coordinating with others,
- Must utilize the powers of observation extensively;
- Hazards are present but controllable and there is potential exposure to disease;
- Performs other related tasks as needed.

**SUPERVISION- RESPONSIBILITY FOR WORK OF OTHER:** None

**EDUCATION, TRAINING, AND EXPERIENCE REQUIREMENTS:**

- Any combination of training and experience equivalent to graduation from high school.
- Must have successfully completed required training courses or will complete within twelve (12) months of hire.
- Must complete continuing education requirements during employment; and
- Must possess a valid Montana Operator's License.

**EXAMPLES OF PERFORMANCE CRITERIA AND EXPECTATIONS:**

- Upon direction, and when no physician is in attendance, shall investigate, analyze, and seek explanation of causes of death;
- May request an autopsy;
- Documents answers in a suitable manner and submits a report to the proper authorities;
- Ability to assess and analyze a scene;
- Be able to communicate all information on a death certificate suitable for filing with the appropriate officials;
- Working knowledge of typing and office skills.
