Eastern Montana Fair Information and Rules Wednesday, August 20 - Saturday, August 23, 2025

- 1. The Home Show Committee reserves the right to refuse any application for exhibit space.
- 2. Exhibitors must provide sufficient inventory of their products for the duration of the Fair.
- 3. Exhibitors CAN NOT sublet their contracted space, without the direct permission of the Home Show Committee.
- 4. BOOTH RULES: Exhibitors must provide their own tables/chairs, signs/banners, and decorate and/or fix booths at their own expense. Exhibitors must provide their own extension cords, and they <u>MUST</u> meet safety requirements. <u>Exhibits must be kept within the boundaries established</u>. The Home Show Committee reserves the right to charge additional fees if the exhibitor exceeds its contracted boundaries. Please DO NOT use any kind of tape in the building.
- 5. Your booth must remain open throughout the Fair's established hours, and not close until the contracted time on Saturday, August 23, 2025.
- 6. The Home Show Committee has the right to limit the operation of any demonstration, if in its judgment, such demonstration causes excessive disturbance to adjacent exhibits.
- 7. Exhibitors, and their sales staff, shall do NO canvassing or soliciting for business, outside of their own booth. This includes wearing a distinctive costume, uniform, or carrying a banner or sign in any area other than inside your own booth, without direct permission of the Home Show Committee.
- 8. The Home Show Committee must be notified, in writing, by August 1, 2025, if an exhibitor is unable to fulfill their contract. THERE WILL BE NO REFUNDS AFTER THAT DATE.
- 9. The Home Show Committee will not offer exclusive product sales to any vendor. However, we will attempt to keep multiple products to a minimum.
